Introduction

This outreach report summarizes the outcome of the second open house for the Winston Transportation System Plan (TSP) Update. The purpose of the open house was to present proposed transportation solutions for the needs identified in previous analyses and public outreach and to gather public input. This feedback will be incorporated into the preferred transportation solutions evaluation and contribute to developing the TSP Update.

The open house was held at the Winston Community Center on Tuesday, September 20, 2022, from 7:00 to 9:00 PM. The public was notified about the event with a flyer delivered by the City as well as multiple avenues on the project website, including emailing subscribers. A copy of the flyer is attached to this report. For community members who preferred to participate virtually, an online survey containing the same information presented at the in-person event was available through the project website. The following sections summarize the feedback received during the open house.

Open House Feedback

Large maps illustrating the proposed solutions were displayed at the open house and comment forms were provided to collect feedback. Other project information was on display, such as the TSP goals, the project schedule, and the project team's next steps in the TSP Update process. Copies of the open house presentation materials and the comment form are attached to this report.

The public showed general support for the solutions and offered the following input:

- People drive too fast down Thompson Avenue
- Fill the sidewalk gap along Baker Street between OR 42 and Gregory Avenue
- The crossing on OR 42 at Civil Bend Avenue serves several crossing movements and should be considered a priority location
- Consider providing an undercrossing of OR 42 near the Winston Bridge for people walking and biking
- Brockway Road north of OR 42 is a narrow road, in relation to the proposed bike lanes
- The proposed bike lanes on Brockway Road south of OR 42 should be development driven






