Project: Town of Lakeview Transportation System Plan Update

Subject: Draft Online Survey Summary

INTRODUCTION

This memorandum summarizes the results of a public survey hosted online to present the transportation solutions being considered for incorporation into the Lakeview Transportation System Plan (TSP) Update. The purpose of the survey was to gauge the level of the public's support for the recommended projects and inquire about other solutions that should be considered. The online public survey was held from March 29 to April 12, 2021 and the public was notified of the event through various outreach methods including:

- 8.5x11 flyers posted around the Lakeview community starting the week of March 22nd;
- Information on the project website;
- ▶ Stakeholder emails sent on March 29th and April 5th;
- A press release to local media on March 25th and April 1st (published in local newspaper on March 31st and April 7th);
- Utility bill inserts distributed the week of March 29th; and
- Digital flyer posted to relevant social media channels the week of March 29th.

The online survey received input from 21 participants. A summary of their input is provided in the following section.

Survey results

The transportation solutions presented in the online public survey included improvements to streets and intersections, emerging technologies, and the bicycle and pedestrian systems. 60 to 90 percent of respondents supported the modal changes proposed with the highest support for changes to the pedestrian system.

This section summarizes the contents of the survey, the level of public support shared for each modal plan, and the public's additional recommendations to be considered in the TSP Update. The project team will consider this input as the Preferred Scenario is developed in Spring 2021.

Intersection and Street Changes

When asked if participants supported the recommended changes to key intersections and streets within Lakeview (see Attachment A for supporting graphics), these were the results:

▶ Yes: 13 (62%)

No: 4 (19%)

▶ I'm not sure: 4 (19%)

When asked if there were other intersections and streets that should be considered for improvements, participants responded with the following:

- ▶ SIStreet near Arthur D Hay and Fremont elementary schools
- S 6th Street between the hospital and US 395
- N E Street between N 2nd and S 1st streets
- Intersections on US 395 between N 2nd and S 1st streets
- ▶ US 395/S F Street

Emerging Technologies

When asked if participants supported the recommended emerging technologies projects (electric bicycle and scooter study, electric charging station study, curbside management strategies, intelligent transportation systems), these were the results:

► Yes: 15 (71%)

No: 5 (24%)

I'm not sure: 1 (5%)

When asked if there were other emerging technologies that should be considered, participants responded with the following:

- Gateway treatments
- ▶ Charging stations in conjunction with improvements at US 395/OR 140
- Charging stations at Lake County Senior Citizens Association (make-shift solution already in place here)

Pedestrian System Changes

When asked if participants supported the recommended pedestrian system changes (see Attachment A for supporting graphics), these were the results:

Yes: 19 (90%)

No: 2 (10%)

I'm not sure: 0 (0%)

When asked if there were other priority corridors that should be considered, participants responded with the following:

- All crosswalks need re-striping as soon as possible
- School Zone areas
- 9th and G streets
- S 9th Street from S F Street to S L Street

When asked if there were other high priority corridors that should be considered, participants responded with the following:

- ▶ The crosswalk on \$ 3rd Street leading into Lakeview High School (west of \$ I Street)
- Downtown sidewalks include E Street

- ▶ US 395 south to Bureau of Land Management (BLM) office
- ► The S 9th Street/Roberta Road/S 3rd Street loop

Bicycle System Changes

When asked if participants supported the recommended bicycle system changes (see Attachment A for supporting graphics), these were the results:

Yes: 14 (67%)

No: 6 (28%)

I'm not sure: 1 (5%)

When asked if there were other local bikeways along Town streets that should be considered, participants responded with the following:

- Education outreach/campaign
- Missouri Avenue
- Roberta Avenue
- ▶ The S 3rd Street/Roberta Road/Outback Bikeway loop

Transit System Solutions

When asked if participants supported the recommended transit system solutions (maintaining existing services, improving service in lakeview, providing weekend service, improving coordination between providers, providing education and awareness of options, increasing regional connections), these were the results:

Yes: 16 (76%)

No: 4 (19%)

I'm not sure: 1 (5%)

When asked if there were other transit needs that should be considered, participants responded with the following:

- Education outreach/campaign
- Safe storage of current transit vehicles/protection from the elements


Additional Input

When asked if there are additional transportation needs and/or solutions that should be considered, participants responded with the following:


- Curbside management strategies in downtown to promote parking turnover














Q1 Do you support these intersection and street changes?










