**Meeting Purpose:** The purpose of the work session was to provide the Planning Commission and City Council with an overview of the project and discuss potential preferred alternatives in Draft Tech Memo #6 and potential policy and code amendments for development of Draft Implementing Ordinances in Task 6.

## **Discussion Topics:**

- High priority/financially constrained how do these go together? financially constrained means it is anticipated to be funded.
- How is the evacuation plan impacted by a 3-lane cross-section on Hwy 101? Motor vehicles are not considered in the plan focus is on evacuating people on foot.
- Sidewalk on seawall should be labeled Multi-use Path
- Does the widening project along US 101 change the project in the John Point Plan for medians and turn lanes? It should be consistent with the plan.
- Flip flop cross-sections south of seawall to have the turn lane/median section on top of the no turn lane section.
- Can we extend it to Patterson Park and Ocean Hills Drive? Yes, however, future streets may warrant left-turns lane further south too. Don't want the TSP to prescribe where. Needs to be based on Warrants.
- Angle parking on OR 34, east of US 101 is an issue. Consider removing.
- OR 34 cross-sections change 6' bike lanes to shoulders in the far east sections.
- Design standards table footnotes correct issue with numbering.
- US 101/OR 34 Look at keeping two NB lanes with a NB through and a NB shared through/right

- Weigh scales gave property owners a 1-year temporary permit trying to block access but the weigh station was supposed to be temporary. ODOT was planning to move it to MP 146.
- ODOT has stopped commercial development in Waldport due to the weigh station.
- Mill Street show an alternative that realigns Crestline to Broadway. Look at a median or no left-turn lanes
- Need an enhanced crossing on Hwy 34 at the post office
- Provide hard copies for the next work session.

## **Action Items:**

- US 101 seawall cross section label the sidewalk as a "Multi-use Path"
- US 101 south of seawall cross section move up cross section with center turn lane
- OR 34 consider removing angle parking
- OR 34 east of Mill cross section lane the bike lanes as "Shoulders"
- Confirm widening project in John Point Plan
- Update footnotes on design standards table
- US 101/OR 34 evaluate option with two northbound travel lanes
- OR 34/Mill Street show alternative that realigns Crestline with Broadway
- Add Street names to all alternatives
- Add an enhanced crossing at the post office
- Check-in with ODOT on the weigh station
